If your account is inactive, email Chris Alfred the name your account is under along with your user ID or email address so she can have your account reactivated. Once you are reactivated, you will see any requirements you need to fulfill on your home page.

## FOR NEW VOLUNTEERS:

All volunteers must create an account at <u>http://www.virtusonline.org</u>. Attached are instructions to complete the requirements. We are part of the Archdiocese of Chicago. Be sure to select St. Paul VI Parish - Riverside as your location.

You will need to:

- Register and attend a Virtus session (online or in person) called Protecting God's Children for Adults (3 hour training).
- Complete a criminal background check. Follow the prompts in Virtus.
- Please provide one personal and one professional reference. This check will be completed by the school office.
- Electronically sign the Archdiocesan Standards of Behavior.
- Complete the attached CANTS 689 form a hard copy must be given to Chris Alfred.
  Do not mail it yourself.
- Complete the Mandated Reporter Training (MRT) (45min training) by going to <a href="https://mr.dcfstraining.org">https://mr.dcfstraining.org</a>. Register and complete the online course. Send a copy of your Certificate of Completion to Chris Alfred. If you already are a Mandated Reporter from another location, please send a copy of your Certificate of Completion (within the past 3 years) to Chris Alfred.
- Complete the attached CANTS 22 form Return to Chris Alfred.
- Read the monthly bulletins and answer the question online. You will be notified by email when a new bulletin is available.
